We require that each membership provide the name, address and telephone number(s) of at least one potential appraiser/judge for each two teams it sends into **REGIONAL** competition. ## **Register your Teams for Competition**

This year you may register your teams using the DI-ON-LINE system on the internet, OR you can register your teams using the traditional method. **IN EITHER CASE TEAMS MUST BE REGISTERED BY 1/15/03** 

## **DI-ON-LINE METHOD:**

#### STEP-BY-STEP GUIDE TO REGISTERING A TEAM PAK and TEAMS with DIONline: Note: You might want to print out these directions and take them with you to the computer when you log on to

register!

- Go to http://www.dionline.org
- You are looking at a screen with a banner up top that reads "DI Online!" Read down the screen, see where it says "Don't have an account yet?...." CLICK THERE!
- You should now be at another screen with a banner up top that reads "CREATE/EDIT PROFILE"
- Type your e-mail address in the E-Mail box so for Mary Jones, for example, the e-mail might be mjones@aol.com then hit the TAB key to go to the NICKNAME box and type your nickname {example: Mary Jones might type "MJ"}
- Then hit the TAB key to move to the Your Name box.
- Type: your first name then hit the TAB key to go to the LAST box.
- Type: your last name
- Hit the TAB key again and go to DAY phone and type your phone number including your area code (XXX-XXX-XXXX) and hit tab again
- Your cursor should now be in the EVENING box type your evening phone number here including area code. If
  your evening phone is the same as your Day phone you can simply type "SAME" and click the TAB key again to
  move on to the FAX box
- In the FAX box type 'same' or the number (including area code) and hit TAB one more time.
- You are now in the DI Affiliate box click on the arrow on the right side of that box to open the pull down menu and select your affiliate
- Hitting TAB now will take you below the blue "REGULAR MAILING ADDRESS" banner to the "Address line 1" box
   - yout house number and street here (example 123 Sesame Street) and hit TAB to move on to the Address line 2
   box. Fill in that box and hit TAB again to move on to the City Box
- Type the name of the town you live in (example: Newark) and and hit TAB
- In the County box type the name of your county (example: Alemeda County) and hit TAB
- In the State/Province Box type your State/Province Name (example: CA) and hit TAB
- In Zip/Postal Code type your zip code (a 5 digit number) and hit TAB again
- In the Country Box type your country name (example: USA) and hit TAB
- If this is a commercial address click in the checkbox to check that the above address is a commercial address and move on to below the SHIPPING ADDRESS Banner
- If you want anything sent to you by DI, Inc. to go to an address different from the one you entered as a mailing address you need to enter the SHIPPING address information here.
- If you want everything sent to you by DI, Inc. to go to the address you just entered simply CLICK in that little checkbox next to "Ship to the mail address above" and a checkmark will appear. Then hit TAB until you come to the "I am 13 or older" check box and click in that little box to check it of you are over 13.
- Now click the CONTINUE button.

- You are now on a screen with a red banner that reads "SET YOUR PASSWORD"
- In the New Password: box type ANY PASSWORD YOU LIKE and will remember and hit TAB then type your password again in the 'again' box and CLICK CONTINUE
- This should take you to your personal start up page...... notice it will say "Welcome, {YOUR NAME}" at the very top, then in the banner it will say TOP DI NEWS FOR {YOUR NAME}....
- Below the banner (which reads WELCOME, {YOUR NAME) you are going to see three options, DOWNLOAD (to download this years Challenges) REGISTER (to register teams online) and PERSONAL DETAILS which will allow you to change any of the stuff you just entered as personal information. You can also return to the DI home page
   but if you do that you are out of the DIONline system and will need to log back on to get back in!
- Choose the REGISTER a TeamPak option by click on the word REGISTER.
- The screen is going to ask you for information about your team what do they want to be called, what school are they from, what school district is that? do they want to select their own passport number? Do they want a single team or a 5-Pak passport?
- Then in the method of payment box you can input a PO # , Check or Credit Card information and finally click CONTINUE at the bottom of the page.
- You are then going to see an order summary page..... it's going to tell you everything you just did...... read through and then click PLACE ORDER or follow the screen directions to edit what you have ordered.
- This time the screen is going to be a THANK YOU screen that tells you how to complete registering your team(s), what you ordered again.....and finally there is an ENTER ANOTHER button at the bottom of the page. IF you hit the ENTER ANOTHER button you will be asked to enter information for another TeamPak - if you are done entering Team Paks, click GO TO MAIN MENU
- Notice your menu has Changed...... look to the right at the top and see the Menu box there? Notice now your choices are up there ..... but what I want you to do next is to look at the "YOUR TEAMPAKS" area and see what it says it shows you the status of your teamPak (it should say NOT PAID at this point) and then it allows you two actions CHANGE or TEAMS you would choose CHANGE to change any of the information you put in for your team. If you click TEAMS you are going to get a screen that has a banner up top that says CURRENT TEAMS and then just below that it says "No teams have yet been registered for this TeamPak".......
- CLICK 'ADD TEAM'
- Now we have the TEAM INFORMATION screen...... this screen is going to ask you for information about a specific team before you had entered info about the TEAM PAK this is about a single team give your team a name, select a level and challenge.... you will want to type in the Team Managers e-mail address if you don't know that leave this box blank and you can fill out all the information you do know about the TM in the next screen.
- Now you get to enter the Team Members by Name, Date of Birth and Grade- just as though you were registering your team for competition the traditional way!
- Then finally at the end you are going to click UPDATE TEAM.

# **REGISTERING FOR A TOURNAMENT THE TRADITIONAL METHOD:**

Included with this newsletter is the **Western** Region team registration form, which must be completed and returned by **1/15/03**. On this form you are asked to submit the names of each team member and Team Manager competing at our Tournament. Please be sure to write, or type the form as legibly as possible as this is the source from which Certificates of Participation and program acknowledgments come. You will also be asked to name the judge/appraiser and volunteer your school has supplied. The <u>WESTERN Team</u> **Registration Form** is on the next page of this Newsletter, fill this form out and return it to Dee Urban, Director
